### 2017 REPORT TO OUR CONSTITUENTS

#### VISION

Living well when serious illness makes life uncertain.

#### WHO IS NHHPCO?

Last year, over 6,500 people were served by New Hampshire's hospice and palliative care programs. Such care has been consistently reported by families to contribute to a much higher quality of life for both the patient and their supporting family and friends.

NHHPCO is the only state-wide organization dedicated to promoting excellence in care for those facing such life-limiting situations by:

- Educating healthcare professionals, and other caregivers, who provide care in hospitals, nursing homes, outpatient, and homecare settings.
- Raising public awareness and expectations for quality hospice and palliative care.
- Advocating for legislative and regulatory changes that improve patient access to quality care.
- Providing professional networking opportunities for membership.
- Engaging organizations to participate with us in our vision and mission.

#### 2016 — 2017 HIGHLIGHTS

- Represented NH hospice and palliative care professionals at NHHPCO Hill Visits and Council of States meetings.
- Advocated for removal of barrier to care in the CMS rule for RHC & FQHC physician billing.
- Hosted key events including the 21st Annual Fall Conference: *The Best Care Possible: Communities of Care*, the 4th Annual Hospice Volunteer Education Day: *Vigil Volunteering*; and, with St. Anselm College, the 4th Annual Hospice and Palliative Care Conference: *Bringing Comfort to Patients with Serious Illnesses*.
- Supported career and skill development through workshops and webinars on topics including improving access to palliative care by successfully billing for services; state hospice protocol for responding EMTs; Hospice and Palliative Care Certification (CHPNA) prep class for Nurses Aides; and Determining Capacity – legal and medical process for enacting DPOA for Healthcare Decisions.
- In partnership with the NH Comprehensive Cancer Collaboration Quality Of Life Task Force, hosted four community screenings of the “Being Mortal” documentary; also partnered with the Palliative Care Team at the VA Medical Center to host a tour of their PC Unit and a screening of the “Soul Injury” documentary.
- Assessed the current status of hospice and palliative care in NH through involvement with the Endowment for Health Tri State Aging Coalition; via surveys of Palliative Care services in all healthcare settings throughout NH, and of advanced care and POLST usage amongst patients; and through participation in the Governor's Commission to study the shortage of nurses and other skilled health care workers for home health care services and post-acute care services.
- Offered Peer Network meetings for Chaplains, Volunteer and Bereavement Program Managers, Hospice and Palliative Care Administrators, and Hospice and Palliative Care Clinicians.
- Held a professionally facilitated Strategic Planning Retreat for twenty current and former NHHPCO board members to explore the mission, vision and future goals of this organization.



## MESSAGE FROM THE PRESIDENT

Dear Colleagues,

**T**he vision of NHHPCO is that all people in New Hampshire will have access to excellent care that is valuable and meaningful to them when facing life-threatening conditions. For families to truly have access to high quality palliative and hospice care, they must be fully aware of the benefits these services provide, as well as where in the illness trajectory they can be elected. Increasing public awareness through our relationships with not only palliative and hospice providers, but also hospitals, skilled nursing facilities, assisted living facilities and other care partners, is one key area where NHHPCO's presence and efforts are making a difference every day. Providing education and networking opportunities to our members via the Annual Fall conference, Peer Groups, and the Annual Volunteer Education Day also stand out as important contributions to ensuring excellent care is provided to the patients and families that need us.

I recently had the opportunity to meet Edo Banach, the new President and CEO of the National Hospice and Palliative Care Organization (NHHPCO). Edo has charged hospice providers with breaking down the silos that exist between for-profit and not-for-profit, large and small, rural and urban organizations, and advocate as one voice for the needs of our patients and families. Similarly, providers across the continuum of care are challenged to continue to manage costs while providing high quality, coordinated care to those they serve. Home care, hospice and palliative providers must have a seat at the table to help shape new care models that benefit our patients. Reinvigorated efforts to strengthen the relationship between NHHPCO and the Home Care Association of NH (HCANH) can only benefit our membership in this new healthcare era. 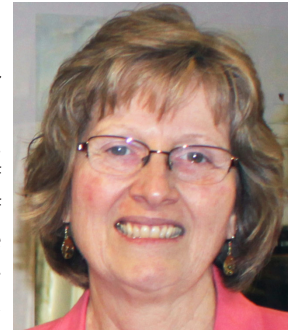

### THE IRA BYOCK & YVONNE CORBEIL AWARD

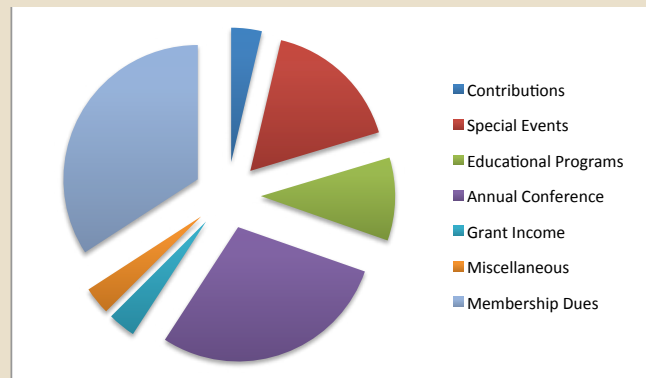
In 2013 NHHPCO established an award to honor the work of Ira Byock and Yvonne Corbeil. The award recognizes an individual, team or organization in Northern New England who has demonstrated innovation and collaboration to help deliver the best end-of-life care possible to NH residents.

Kelly Doherty, RN-C, MSN, ARNP-BC was the recipient of the 4<sup>th</sup> Annual Ira Byock and Yvonne Corbeil Award for Innovation and Collaboration in Delivering the Best Care Possible.

Kelly is the Director of the Palliative Care Program at Cornerstone VNA and has been instrumental in its success since the inception of the program in September 2014. She serves as a liaison to local area hospitals and collaborates with assisted living facilities and skilled nursing facilities to ensure that the Palliative Care Program is meeting the needs of the community. Additionally, Kelly serves on the Cornerstone VNA Medical Directors' team and trains all Cornerstone VNA Home Care nurses in pain and symptom management. According to Hospice Director Andrea Patrick-Baudet, RN, CHPN, CHPCA, "Kelly's ability to mentor and teach home care nurses about palliative interventions has had a monumental impact on earlier treatment of symptoms for patients with chronic illness, whether they are not yet eligible for hospice or are choosing to continue a curative philosophy of care."

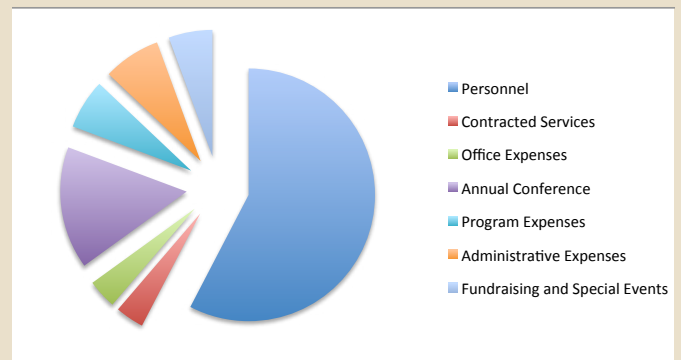
## NHHPCO FY 2016 REVENUES AND EXPENSES
